Guillaume Rose

Guillaume Rose was born on 6 January 1969 in Monaco.^[1] He studied screenwriting and graduated from the [Sorbonne](#) in Paris with a Master's degree in film studies.^[3] For four years, Rose lived in Paris working in TV and film industry before coming back to Monaco in 1997. He started working in communications for the [Société des Bains de Mer](#) (SBM) becoming head of the department responsible for promoting gaming.^[3] He obtained a Corporate MBA at [International University of Monaco](#).^[1] After that, Rose went to [Las Vegas](#) to gain experience in hotel and casino management.^[3] Upon returning to Monaco, he was appointed Executive Assistant to the CEO of SBM and then took responsibility for entire Communication Department of the group.^[3] Rose left SBM in 2010 and the same year he joined the Principality's Tourism Department becoming the President of the Monaco Tourism Authority of the Principality of Monaco in 2011.^[3] In 2019, Rose was appointed an Executive Director General of the Monaco Economic Board.^[4]
